As with any fuel source, it is important to follow proper safety precautions when using natural gas in your home or business. Improper installation, use or maintenance of gasburning appliances, piping and venting can create dangerous conditions. This Notice identifies potential home safety hazards and provides information on how to be safe around natural gas.

APPLIANCE CONNECTORS



Appliance connectors are corrugated metal tubes used to connect gas appliances to fuel gas supply pipes in your home or business. Some older brass connectors have a serious flaw in how their tubing was joined to their end pieces. Over time, the end pieces can separate from the tubing and cause a serious gas leak, explosion or fire. To our knowledge, these dangerous uncoated brass connectors have not been made for more than 20 years, but many of them are still in use. The older these connectors get, the greater the possibility of failure.

Although not all uncoated connectors have this flaw, it is very difficult to tell which ones do. Therefore, any uncoated brass connector should be replaced immediately with either a new plastic-coated brass or a new stainless steel connector. Connectors can wear out from too much moving, bending or corrosion. Connectors should always be replaced whenever the appliance is replaced or moved from its location. If you believe that you have an older connector in your home, have a qualified contractor inspect the connector and replace it if necessary. Do not attempt to check connectors yourself.

Moving the appliance, even slightly, whether to clean behind it or to inspect its gas connector, can cause the complete failure of one of these older weakened connectors, possibly resulting in a deadly fire or explosion.

Be sure to follow these appliance connector safety guidelines:

- Make sure that connectors are installed where no one will step, sit, lean or place a heavy object on them
- Never have a connector installed through a wall, floor or ceiling
- An appliance connector should not be more than six feet long
- Each appliance should have a shut-off valve installed on the house piping before the connector
- A new connector should be installed every time an appliance is replaced

GAS LEAKS

Gas leaks can be very dangerous, possibly resulting in a deadly fire or explosion, so be sure to know the signs of a gas leak and what to do in an emergency. There are three ways in which you can detect a gas leak:



Smell: Natural gas is injected with a distinct odor, which many people equate to that of rotten eggs. Contact Nicor Gas for a scratch 'n sniff card with this scent.

Sight: Visible blowing dirt, bubbling water or discolored vegetation near a buried natural gas line.

Sound: A hissing or blowing sound near the gas meter or gas appliances.

CALL BEFORE YOU DIG

A damaged gas pipeline or service to a house may create an explosion hazard resulting in injury or death, severe property damage and loss of vital service. If you or a contractor will be digging, trenching, drilling, grading or excavating on your property, the person doing the digging is required by state law to contact JULIE at least 48 hours in advance (not including weekends and holidays). JULIE is the one-call system for locating all underground utilities and can be reached at 811 or 1 800 892-0123. You can also make an online E-request at **illinois1call.com**. If you reside within Chicago city limits, call DIGGER at 1 312 744-7000. If you suspect that gas is leaking, follow these steps:

Emergency Procedures

- Exit the building or area immediately, leaving doors and windows open as you exit. Do not open windows if they're not already open. Do not use your telephone or cell phone, operate any appliance, light a match or turn light switches on or off.
- 2. Call Nicor Gas at 1 888 Nicor4u (1 888 642-6748) from a neighboring location.
- 3. Wait at the neighboring location until Nicor Gas determines it is safe to return.



GAS PIPING

Nicor Gas is responsible for maintaining the gas lines that deliver natural gas to the meter at your home. You are responsible for maintaining the gas lines from the meter to the natural gas-burning appliances throughout your home and property – indoors and outdoors, above and below ground. You may have gas lines extending to yard lights, grills, pool heaters, and garage or workshop heaters.





Customers' Responsibility Most meters are "attached" to the house or building.

If you have an older home and do not have a basement, the gas line from your meter to your pipes and appliances may be piped below the slab on which your home rests and enter through the floor. If this is the case, it can be difficult to monitor the gas line and detect a gas leak. Have a qualified contractor inspect and, if advisable, re-route the gas line from the meter above ground to an appropriate place so that it can be easily monitored. Above-ground gas pipes in your home should never be used for unintended purposes, such as hanging clothes.

If there is a distance of more than three feet between the meter and your home, Nicor Gas monitors only the primary pipeline for corrosion and leaks. However, you are still responsible for repairs on these lines. Problems with your natural gas piping and appliances can be dangerous and costly. You should have all natural gas piping that is not monitored by Nicor Gas periodically inspected for leaks, corrosion and other potential problems. Ask a qualified contractor to perform this inspection during the annual inspection of your gas appliances. Whenever gas appliances are disconnected in your home by a qualified contractor, the gas connectors should always be removed and the fuel line should be plugged and capped.

CARBON MONOXIDE

Carbon monoxide (CO) is odorless, colorless and tasteless. It is produced when any fossil fuel, including natural gas, is burned. When fossil fuels do not burn properly, CO can build up and cause sickness-even death. CO can build up when gas appliances are used improperly or are not vented properly.

Safety measures:

- Never heat your home or apartment with your gas range or oven
- Have your gas appliances and heating systems inspected annually by a qualified contractor
- Per Illinois law, install CO detectors in your home near all sleeping areas. Follow the manufacturer's installation and use guidelines

Symptoms of CO poisoning:

- Dizziness, nausea, headache and coughing
- Irregular heartbeat
- Pale skin with cherry red lips and ear tips
- If you suspect CO poisoning:
- Get fresh air and stay outside
- Call 911 or the local fire department

KEEP COMBUSTIBLES AWAY FROM IGNITION SOURCES

Please use caution when storing paper, boxes, clothing, wood or other ignition sources, making sure they are always a minimum of three feet away from furnaces, hot water heaters and space heaters. Because their vapors can easily ignite, it is highly recommended that gasoline,

paint and all other flammable liquids be stored away from living areas. A cool, ventilated area of a shed or garage is a good location. Flammable liquids should only be stored in approved containers and never in plastic milk jugs or glass containers.

USE CAUTION WITH SPACE HEATERS

Space heaters can take the chill out of a room, but they should always be used with caution. If you use a space heater, make sure it includes a tipover switch that shuts the unit off automatically if it accidentally turns over. Keep space heaters off carpeting and

PREVENT SCALDING

Each year around 3,800 burn injuries and 34 deaths are caused by excessively hot tap water. To avoid scalding injuries, it is recommended that your hot water temperature not exceed 120° F. Always be sure to check water temperature before placing a child in a bathtub and never leave a child alone or with younger children in a bathtub. Lowering your water heater temperature also has the added benefit of reducing your natural gas use, which translates to an energy cost savings on your bill.

GAS APPLIANCES, HEATING SYSTEMS AND VENTING Gas appliance valves that are missing or not



WATER HEATERS

Be sure that your water heater is set at a temperature recommended by the manufacturer. Have your hot water heater checked by a qualified contractor annually

NATURAL DISASTERS

Floods and tornados are common in the Midwest. Should your property be affected by these or other natural disasters, it is recommended that you inspect for natural gas leaks, as appliance connectors and gas piping may

for proper installation and operation. Be sure that the Temperature Pressure Valve discharge tube ends at least 12 inches from the floor (see illustration). The tube should not be threaded at the end nearest the floor.

be impacted. If a leak is suspected, follow the procedures shown in the "Gas Leaks" information. It is recommended that any gas appliances that have been submerged in water be replaced.



GAS METERS

It is important that Nicor Gas has full access to your meter and that you keep it clear of obstructions that can these tips: damage your meter or prevent us from reading it. A damaged meter can lead to a dangerous gas leak. If you believe your meter has been damaged, call Nicor Gas immediately at 1 888 Nicor4u (1 888 642-6748).



Do Not Move Meters and Regulators

If your gas meter needs to be moved, call Nicor Gas to have a qualified Nicor Gas service representative perform the work. Moving or tampering with a meter or regulator can cause a hazardous gas leak. A limited number of regulators in the Nicor Gas system contain mercury. Improper handling or removal of such regulators can cause hazardous mercury spills.

Only a Nicor Gas representative is authorized to move your gas meter or regulator. Do not attempt to move or tamper with your gas meter, regulator or any associated piping or permit anyone else to do the same.

Snow and Ice

Snow or ice buildup covering the outside venting of a furnace, water heater or clothes dryer can cause a hazardous buildup of carbon monoxide. The regulator on your gas meter has to be able to release gas in the event of a malfunction. If ice or snow covers the vent, the regulator will sense that it cannot release gas. As a result, the entire system will automatically shut down, stopping gas service to your home. Snow removal that damages or dislodges your gas meter can cause a dangerous gas leak.

To prevent problems, follow

- Use a broom (not a shovel) to clear snow from your meter, regulator, and vents
- Sweep snow away from the outside vent openings of natural gas appliances (such as clothes dryers, hot water heaters, and high efficiency furnaces which vent to the outside of the home)
- Remove icicles hanging above your meter
- Be sure whomever removes snow from your property is aware of the placement of your meter if it is near a sidewalk or driveway

Mulch Near Meters

Do not place mulch around the meter. It is combustible and can cause a fire that could ignite natural gas that flows into and throughout your meter.

Other Obstructions

If your meter and/or regulator is located where other objects could possibly collide with or damage the meter and/or regulator, you must install physical protection (such as a guardrail or steel post).
